- a. updating of current by-laws
 - 1. proposal of changes to bring before the community
- i. Update mission/vision statement to match current mission/vision statement.

- iii. Change name from Coordinating Council to Site Council
- iv. In reference to parent members: parents will have application submitted by $3^{\rm rd}$ quarter rather than a certain date. The change is in reference to having quarterly meetings rather than monthly meetings. Then it is not in our last meeting.
- v. For clarification: facilitator can be a teacher and voting member if the parent teacher ratio was equal. There needs to be an equal number of teachers to parents.

- vii. The members attendance should be at least ¾ meetings per year.
- viii. Meeting times changed from monthly to quarterly and emergency meetings as needed.

- xi. Add: If we have a Community Liasion that person will be a permanent member not subject to the two-year limitation
- xii. Amendments proposals will be brought before the PTA in December to be voted on.
