District and school personnel will assist in the planning and implementation of parent and family involvement services to improve student academic achievement. Employers, business leaders, and philanthropic organizations, are invited to be a part of the committee working on the school/district Integrated Action Plan. Through participation of diverse representation of our families and community our school/district will develop a plan that is unique to the needs of our student and family population.

## Annual Evaluation

The Tucson Unified School District with the involvement of parents, will use multiple data sources and conduct an **annual evaluation** of the content and effectiveness of this parental involvement policy. The evaluation will include identifying barriers to greater participation by parents in family engagement services (with particular attention to parents who are economically disadvantaged, who are disabled, who have limited English proficiency, who have limited literacy skills, or are of any racial or ethnic minority). The district will use the findings of the evaluation about its parental involvement policy and services to design strategies for more effective family engagement and revise as needed.
