c. Walk-A-Thon

- i. Change of date voted to October 30, 2024
- ii. Jasper and Monica are creating flyers and pledge sheets
- iii. Monica will create a QR code and add to flyers and pledge sheets
- iv. Halloween costumes are encouraged for that day
- v. Jasper will create an online form for students to sign up online.
- vi. Andy investigated our bank accounts for payment options. We will offer Zelle and Venmo, as well as cash or check for payment options.
- vii. There were concerns for offering tax credit as payments this year
- Linnea questioned of there are risks to making payments as tax credit donations (i.e. parents keeping track of donations, etc.)
- Erika questioned what the benefit is for a parent donating as tax credit. Benefit is more on the school side (helps pay for gardening, field trips, and benefits the kids and community).
- Tia explained that it decreases the overall tax liability
- There is also a concern for double dipping. PTO might not profit as much if tax credit option is available.
- Ellen suggested instead of using tac credit "donation" to use "designate" instead
- Tax credit option was taken off the table this year by Mrs. Steele
- viii. Jasper and Andy will figure out final payment ideas (QR codes, online payments, etc.)

d. PTO Transition Committee

- i. Met this past Saturday (Jasper, Andy, and Josh)
- ii. There are two avenues to take- state or federal
- -Go with state first before going federal because there is a fee with federal
- iii. Josh explained for the state PTO needs to get incorporated with a form then pay a \$40 fee
- -will need to update bylaws but do not need to submit
- -need to provide two names and addresses: (1) Incorporator, and (1) Directory
- -the state will mail acceptance
- -will need to publish existence in newspapers
- iv. Jasper will be in contact with the committee to continue process
